My name is **Barry Rowe** and I'm running for the Champaign Unit 4 school board. I retired in June, 2004 after 33 years of teaching. 25 of those years were in the Champaign schools. I have taught Mathematics, Physics, Chemistry and Computer Science in Champaign and in Danville, Oakwood, at the Illinois State University High School, Storefront School, and Parkland College. I also served as educational technology director for the Champaign schools for 4 years. My wife is a first grade teacher at Bottenfield school in Champaign and both of my children attended the Champaign schools and are now in college.

I believe we need to provide the best education possible for all students. The current concern about the African-American student achievement gap needs to be faced not just so we can "get out from under" the court's consent decree, but because it is right. All students can learn and our schools have not done as well as we can to close the achievement gap. But the current method of facing this problem is ignoring those who will help these students the most -- the fine teaching staff of the Champaign schools. For true learning to take place, we must support the people who are in the front line of education do their job. True educational reform comes out of dedicated teachers deciding to make changes. This cannot be dictated by the board or administration. Support and respect for the teaching staff is what will make these reforms successful. The administrative team needs to see that the board expects them to work with the teachers -- not micromanage them. There needs to be a change in the board.

Hi, I'm **Arlene Blank**, a candidate for the Champaign Unit 4 School Board. I retired from the school district in June 2002 after 29 years, the last 16 as the Assistant Superintendent for Support Services.

I am very knowledgeable about the District and am very concerned about its recent fiscal problems. Unit 4 has been the beneficiary of several years of sustained economic growth in Champaign and Savoy. Growth which has provided significant financial resources for the District.

Unfortunately, in little more than two and one half years the District has found itself with a debt of almost five million dollars. A debt which will require significant budget cuts, cuts which will result in lost positions among the teaching, support and administrative staffs.

At a time when the District is focusing on increasing academic achievement, it must cut its budget. Cuts of two million dollars in fiscal years 2006 and 2007 along with one million in 2008 will hamper these efforts.

Discussion on how to continue to provide the quality education which Unit 4 owes to its students and taxpayers has not to date addressed the need for a written fiscal plan which would lessen the impact of the budget cuts and develop ways and means whereby the District will live within its budget and avoid the fiscal problems in future years which it now faces. The District needs to permanently employ a Business Manager with the expertise to manage an 80 million dollar budget. The voters in Unit 4 need to elect Board members, on April 5, who will pay attention to fiscal affairs rather than apparently approving expenditures without sufficient study and realizing the impact they will have on the budget and ultimately student achievement.

I am asking you to cast your vote for Arlene Blank , on April 5, and I pledge that I will work diligently to serve as a Board member who sets policy and not micro manage and work with my fellow Board members to develop a fiscal plan which provides for a balanced budget which the District can live within and continue to increase student achievement.

Good morning, my name is **Dave Tomlinson**, and I am a candidate for the Champaign schools unit 4 board of education. My family and I have lived in the Champaign area for almost 20 years. We have two children in the district, a daughter at centennial and a son at Jefferson.
