As the MACU & V President, I am continually enthusiastic and excited about how God has allowed me to be his instrument to lead our team to work to bring the clergy closer together and expand so the MACU & V members will look more like "Heaven" on the Earth.

We are still working to bring our congregations together as "one" as we seek to change Champaign-Urbana and Vicinity for the better. As we reflect on 2009, we see that we were involved in several areas: (1) Consent Decree for Champaign Unit 4 Education, (2) Letter to the U.S. Department of Justice, (3) Urbana School District 116 and Budget Cuts, (4) Soldiers in Iraq, (6) Retreat, (7) Call to Action, (8) Urbana Civilian Police Review Board, and (9) the MACU & V 2009 Awards Program.

Consent Decree for Champaign Unit 4

We worked tirelessly with parents and children to keep the Consent Decree alive by writing letters to the Honorable Judge Billy Joe McDade.

President Underwood and Rev. Jimmie O. Holmes were allowed to speak before the judge. As part of the final order, Judge McDade included language from the Superintendent and President of the School Board that will allow the community to hold the school district accountable to the spirit of the Consent Decree. Letter to the U.S. Department of Justice

On December 28, 2009, the MACU & V sent a letter to the Criminal Section of the U.S. Department of Justice requesting the investigation of the fatal shooting of 15-year-old African-American male named Kiwane Carrington by Champaign Police Department Officer Daniel Norbits which occurred on October 9, 2009.

Our letter to the U.S. Department of Justice ended with the words: "We, as spiritual leaders of this community, feel that Kiwane Carrington's blood is crying out for justice" (Genesis 4:9-10).

In response to our letter, we received a letter dated March 5, 2010, from the U.S. Department of Justice confirming that the FBI is currently investigating the shooting. Once the investigation is complete, the FBI will forward the results of that investigation for review by the Criminal Section of the Civil Rights Division. The letter from the U.S. Department of Justice noted, "please be assured that if the evidence shows that there is prosecutable violation of federal criminal civil rights statues, appropriate action will be taken."

Urbana School District 116 and Budget Cuts

Currently the Urbana District is facing severe budget cuts. Therefore, we expressed support by attending Board meetings to prevent the loss of the following positions and programs that directly benefit African American students: (1) District Parent and Community Outreach Liaison who serves our African American children and families and is currently filled by Janice Mitchell. (2) Minority Enrichment Program Coordinator who serves African American students at Urbana High School and is currently filled by Kellie Marshall. (3) Alternative Education Program which allows students (majority African American) alternative opportunities to make up class credits toward promotion from middle school and graduation from high school. The Director of this program is Grace Mitchell.

Soldiers in Iraq

While communicating with her son, who is stationed in Iraq, Ms. Bernice Harrington of Bethel African Methodist Episcopal Church was moved with compassion when she discovered that many of our minority soldiers were receiving very few letters and care packages from home.

With the assistance of the MACU & V an action plan was formulated to let our soldiers know how much we appreciate their dedication and sacrifice for freedom and democracy. Through the Women's Missionary Society of all the churches in the Chicago and Illinois Conference of the African Methodist Episcopal Church, The Don Moyer Boys and Girls Club of Champaign County, Church Women United and individual churches in our community, care packages and letters are being sent to our soldiers.

Under the supervision of Mrs. Lovia Henderson and the direction of Mrs. Anita Lott, the YDP Director of Bethel AME Church, our youth knitted 75 caps for the helmets of our soldiers. The alarm bell went off, but we sat on the sideline of neutrality and watched silently as our historical organization, that gave assistance to the disenfranchised citizens of our community, closed its doors and now ceases to exist.

Another wake up call went out to our community when The Don Moyer Boys and Girls Club was in financial trouble. This time, the alarm cut at the very fiber of our existence, because it dealt with our children; bone of our bone, flesh of our flesh and the lifeline of our community.

The MACU & V, by the grace of God, saw the handwriting on the wall and quickly mobilized our community to action. As a community, we came together and took control of our destiny by pooling our resources and sponsoring our children. The action that we took has forever changed the face our community and empowered us as a people, to come together and take control of our destiny. We can no longer afford to be mere benefactors of our historic organizations and not become financial contributors.

We are living in a changing world and we must respond to the change of the time. Change can be a simple and ordinary experience with extraordinary results or formidable moments that have impact not only upon the individual but entire populations for generations to come.

There is a quote in a book titled, The Destruction of Black Civilization: "What became of the Black People of Sumner?" the traveler asked the old man, "for ancient records show that the people of Sumner were Black. What happened to them?" "Ah, the old man sighed. They lost their history, so they died."

A wake up call is circulating in our community and it is a call to action and community involvement. Will we heed the alarm and respond accordingly, or will we sit passively on the sideline of neutrality, forgetting the lessons of our past and slowly watch our historic organizations cease to be? The Don Moyer Boys and Girls Club need our help. It only takes \$558.17 to sponsor one child for one year. What is the investment that you are willing to make in order to guarantee our children a future in our community?
