## I'LL ALWAYS LOVE MY MAMA

June The The With so much going on in the world today, God and Mothers are the only things we have to depend on, respectively. We learn at an early age that through spiritual guidance, God is the only constant we have in our lives we can totally depend on. He is a Spiritual Guide, a Comforter, a Healer and many more things. However, one thing is also certain – He gave us mothers here on earth to instill in their children the way He wants us to live. He also gave us mother figures when we have no mother to care for us or ones who will not concentrate only on the needs of their own children but others as well. That is truly demonstrated in the life and family of Willeta Donaldson. She has been a Spiritual Guide, a Helper, a Comforter, a Provider, and Healer among other things that make her the "Mama I'll always love!" I feel she is worthy of this Mother of the Year Award because of the many God-given talents she uses in her everyday life, no matter the situation or the people involved.

> As a young girl, my mama would sit on her porch on Sunday mornings, dressed in Church clothes, waiting for people to pass by and asking them: "Are you going to Church?" They would respond "Yes." She then would ask "May I go with you?" And again, for whatever reason – they were special people of God also – they would say "Yes." She would go with these people to Church and if events were going on all day at Church, she would be there. This, I believe, began her Spiritual Guidance teaching and singing in the Church, which she has continued to do over the years; using the gifts God gave her to minister to others in song.

> Upon graduating from high school in 1958, she began employment at the University of Illinois in Admissions and Records where she remained until retirement in 1995. During her employment, she assisted many students on getting into and staying in college, whether they were general students or athletes. She also assisted other U of I employees in their jobs as needed, in whatever capacity they asked. Whatever she could do to help people and further herself in her job, she did. She became the 1st African American Stenographer when she started at the University as well as the 1<sup>st</sup> African American Administrative Assistant. Regardless of the situation or people involved, she was a Provider to her family and a Helper to many others.

> She met and married Carlos Donaldson over 45 years ago and raised three (3) children. When we were younger, she worked nights at the U of I (my dad worked days) to make sure there was someone home at all times for us children. She made sure we had breakfast and were dressed before sending us to school and prepared some meals during the day so that we could eat when we arrived home from school. This is when my dad would take over while she worked evenings. She was available during the day to visit our schools, attend conferences or do whatever else was needed by the school or teachers to aid in our education. If she encountered things going on with other students she would relay this information to the students' parents who could not or would not go into the schools to see what their children were doing. As we got older and, she participated in the P.T.A. and assisted my dad, who by that time was on the school board, by attending school board meetings and getting other parents to be involved in their children's education. She was truly involved in the education of her own as well as other children in the community.

Again, she is a Helper and I will always love my mama.

As we grew up, she made sure we were active in, not just going to, Bethel A.M.E. Church, where we all still attend and are active in today. We were active in Sunday School and Vacation Bible School (which she taught for a few years), Church, the Youth Choir, Young People's Department (Y.P.D.) and whatever else was going on. Today, she is an active member of the Bethel Choir, Bible Study, Stewardship and Finance Committee, Benevolent Committee and Usher Board. She is a Spiritual Guide to many at the Church.

While I attended the University of Illinois in the early 1980's, my mama was not only mine, but countless other students as well, having them over for dinner or just to relax. That is one reason why she earned the award of U of I Black Mom of the Year in 1981, being that "Mom away from home" for many students away from home and needing guidance to make it through. Some of the students even came to Church with our family, because she knew they had grown up in the Church and did not want them to lose sight of their upbringing just because they were away from home. Hmm – a Spiritual Guide.

While all of the above was going on in my mama's life, she dealt with 2 grandsons who were each born prematurely (she would go to the hospital intensive care units and sing to and pray for not only her grandsons, but to the many other babies there). When it was time for her grandsons to leave the intensive care unit, the nurses would ask her to return to provide the "therapy" these babies so needed in hearing her voice each day. (She obliged and went back). She also dealt with the following: a sister who for many years was very ill and eventually passed on Christmas Day 1996; an terminally ill nephew (who passed away on New Year's Day 1995); a niece who suffered a massive stroke in 1998 (she had 4 young children and her mother had previously passed away) and an ill mother who passed away in March 2003). While many others may have given up, mama kept praying and singing, while comforting them and indirectly helping to ease their pain and still able to keep her own family together, never once complaining of the things she had to do. She is a Comforter and Healer and I'll always love my mama.

Through everything that has gone on, my mama has prayed, sang, spiritually guided, comforted, provided and helped not only her own children and family, but others as well. That's why I love my mama. If the world had more mamas like Willeta, what a better world this would be. A Spiritual Guide, a Helper, a Comforter, a Provider, and Healer – that's what God put her on earth for and she has honored that role everyday of her life which makes her most deserving of this award. She deserves this and much more because she is my mama and she's loved!

When you look up the definition of mother you find the word nurture, strong, caring female; a woman who puts her child(ren) first. When most of us think of mothers, we all think that our mothers fit that definition to perfection.

Some would perceive this as spoiling, but in actuality she is supporting us in our activities. She believes that it is her job to take as much pressure off of us so that we can focus on performing well. She believes in family support.

She is wise and observant. Bertha Mitchelts is a woman who pays attention to her children and protects them while teaching them life lessons. She has two children; a son and a daughter. Currently her son is attending high school a Culver Academy and is excelling well, independently. Within his first semester he made the honor roll. He is also an accomplished hockey player, black horse trooper, and polo player.

Her daughter is a graduate of Illinois State University with two degrees in Politics and Government and International Economics, and is currently studying law. Both of her children strongly feel that their accomplishments would not have been met without the support, the sacrifice, and the teachings of their mother.

Her son writes:

"What do we think of when we think of great mothers? Maybe someone who lets you bring friends over, go to the mall, to parties, or stay at a friends over night. In my opinion that is not what a great mother is.

In my opinion a great mother is a mother who calls all of your teachers every week to make sure that you are doing well in school.

A great mother is a person who works three jobs to make sure her children have what they need and rarely buys something for herself.

To me, a great mother drives three hours after working all day, to make dinner for your entire dorm just to surprise you on your birthday.

To me that's a great mother."

But her nurturing, caring, and strength doesn't stop with her children. Bertha L. Mitchell is also a substitute teacher who has made a difference to every child's life that she has come into contact with.

She has taken children who had trouble reading, writing, or the concepts of math and gave them the confidence in themselves to succeed.

During the Tsunami tragedy she took a geography lesson and motivated her 5<sup>th</sup> grade class to become world leaders and raise over \$500 for the victims.

But you don't have to take my word for it, walk into her 3<sup>rd</sup> grade classroom today and you will find gifted children exceeding the limitations that others have placed upon them. When asked how they liked having Ms. Mitchell as a teacher, one 3<sup>rd</sup> grader replied, "I like having her [Ms. Mitchell] as a teacher. She teaches us a lot of things and how to be polite."

Bertha Mitchell often takes children with special needs or children which society or the school systems has given up on and make them into a productive citizen. During the summer months, with the permission of the parents, she takes the children and have them help with her catering company. She takes this opportunity to show them how to manage a business, and the importance of responsibility.

Bertha Mitchell does not limit her nurturing style to her own children. She teaches many while providing nurturing for others, and strength to all. That is why Bertha Mitchell deserves the mother of the year award.
